NOTIFICATION

Subject: Extension of timeline for renewal of membership in ONEA for the Year 2025.

Dear Members,

As per Rule 2 of the Bye-laws of the Odisha Nursing Employees' Association (ONEA), renewing membership by paying fees is mandatory for all members. Failure to do so will result in the cessation of membership.

The Association has previously issued multiple notifications and circulars, urging members to complete their renewal before the last date, which was **07.03.2025**. However, during the General Council (GC) meeting held on **13.03.2025**, it was observed that some members have yet to renew their membership.

To provide an additional opportunity, the GC dated 13.03.2025 have unanimously decided to extend the renewal deadline as follows:

- 1. For members contesting for any office bearer position – Last date: 17.03.2025**
- 2. For all other ONEA members – Last date: 19.03.2025**

As per the Association's decision in the GC meetings, **inactive members will not have the right to participate in the election process and no complaints regarding this matter will be entertained.**

Important Instructions:

- Membership renewal must be completed **online only** to ensure a fair and transparent process. **No offline renewal will be allowed.**
- Members must submit the **mandatory documents** while renewing their membership in ONEA to verify their bona fide status. This will also enable the Association to issue **E-Membership Cards and Voter Cards.**
