Dear Sir/Madam,

As per the decision of the GC meeting of ONEA dated 02.02.2025, the election to the post of office bearers of ONEA was to be completed in the month of April, 2025 and the existing office bearers were authorized to discharge their duties in the Association until the new elected office bearers take charge of their respective offices in ONEA. Accordingly, the tentative date of Biennial General Body meeting and election of ONEA was scheduled on 06.04.2025 & 07.04.2025 and the Government was requested to grant special CL in respect of members to attend the Biennial GB meeting. In the meantime, the logistic arrangements to conduct the GB meeting was already made for smooth management. It is a matter of great regret that, the required special leave for the above purpose has not been granted by the Government till date on the ground that some miscreants have submitted their objections and the same is under examination at the Government level. This Association have already submitted its comments on the objections but the decision of the Government for grant of special CL is still awaited.

In order to discuss the above situation and to streamline the future course of action, the emergent meeting of the General Council is scheduled to be held on 06.04.2025 at 11.00 a.m at ONEA Headquarter, Bhubaneswar and a resolution in this context is to be passed.
