This is for your information that the Odisha Nursing Employees Association is going to hold its General Council meeting at ONEA House on dt.04.08.2024 at 11.00 a.m for discussion about various persistent issues of Nursing Officers.

You are well aware that the ONEA have put forth 10 point charter of demands before the Government on dt.05.07.2024 in the welfare of Nursing Officers of the State and in the meantime, the Government in H & FW Department have issued notifications pertaining to fixation of seniority of Nursing Officers appointed prior to 12.11.2013 and regularisation of 1022 inducted Nursing Officers but there are several ambiguities existing on such notifications which necessitates a threadbare discussion in the GC meeting of ONEA. Besides, most of demands of ONEA are remaining unfulfilled despite of continuous correspondences made to the Government for which a meticulous discussion is also required in the GC meeting so as to take further course of action.

In order to consider and take decisions on the persistent issues of members of ONEA and in consonance with the decision taken in the online meeting of State Executive Committee of ONEA dated.16.06.2024 and the unanimous decision taken in the emergency online meeting of ONEA dated 23.07.2024, the General Council meeting of ONEA has been scheduled to be held on dt.04.08.2024 at 11.00 a.m.
