Sub: Decision of the General Council meeting of ONEA held on dt.04.08.2024 to initiate different agitation programmes due to non fulfilment of 10point charter of demands.

Esteemed Madam,

With most humble submission to the Chair, we would like to inform that the General Council meeting of the Association was held on 04.08.2024 at Bhubaneswar to review the progress / fulfilment so far made on different demands earlier submitted before the Government in the Association letter No.146/ONEA2023 dated 05.07.2023, No.85/ONEA /2024 dated 05.07.2024, No. No.131/ONEA/2024 dtd.26.07.2024 and finally in No.171ONEA2024 dated 29.07.2024 (all copies enclosed). After a threadbare discussions and various arguments raised by the most of members of the District Committees, it was unanimously passed that most of demands have not yet been considered by the Government with proper spirit for which there is continuous suffering of the members of Nursing Cadre even in spite of repeated negotiations and persuasions made by the office bearers of the Associations.

With reference to demand No.01, although the Government have issued notification dated 22.07.2024 to confer seniority from the respective year of recruitment in respect of the Nursing Officers recruited/ appointed prior to 12.11.2013, they are not conferred with all other service benefits including financial up-gradation, arrear incremental benefits and promotional benefits etc. for the contractual period of service already rendered even though recruited by following the principles set out by the Government in the year 2005, 2007 and onwards. It is further taken to notice that even though similar benefits are already allowed to the JEs under the Water Resources Department but the same benefits are not extended to the senior Nursing Officers.

Besides, the demands mentioned at Sl. No.03 to 10 have not yet been taken into consideration even after the lapse of substantial time period.

Accordingly, it has been felt unanimously by the GC members in the meeting that the sufferings and wretched financial condition of the Officers of the Nursing Cadre has not yet been taken into concern on the part of the Government and it seems that the demands are being handled in a delaying tactics. Finally it has unanimously been decided as a token of protest to start wearing "Black Badge" for 7 days w.e.f dt.14.08.2024 and to hold token strike w.e.f dt.21.08.2024 and mass rally at lower PMG, Bhubaneswar on dt.23.08.2024 without hampering emergency service and cease work from dt.27.08.2024 for indefinite period so as to draw the kind attention of the State Government to fulfil all legitimate demands of the Odisha Nursing Employees Association.
