Subject: Extension of timeline for membership renewal and nomination submission.

Dear Members,

The Association previously issued several notifications and circulars urging members to complete their membership renewal by the last deadline of 19th March 2025. However, during the Election Coordination Committee meeting held on 22nd March 2025, it was noted that some members were unable to renew their membership due to network issues and unforeseen circumstances, as outlined in the representations received from members.

In light of this and to provide an additional opportunity, the Election Coordination Committee has unanimously decided to extend the deadlines as follows:

Membership renewal deadline extension:

The membership renewal deadline is extended by three (3) days from dt.23.03.2025 to 25.03.2025.

Nomination submission deadline extension:

The original deadline for nominations was 21st March 2025. It is now extended by one (1) day, particularly to 26th March 2025, with the submission time being from 10:00 AM to 5:30 PM.

- o Withdrawal of nominations: 27th March 2025 (Time:10:00 AM to 5:30 PM)
- Scrutiny of nominations & publication of final candidates list: 28th
 March 2025

Besides, as per the decision taken in the GC meetings and the Election Coordination Committee on 22nd March 2025, members who fail to renew their membership by the extended deadline of 25th March 2025 will not be permitted to
