2. Election of Branch Representatives of ONEA (2025-2027):-

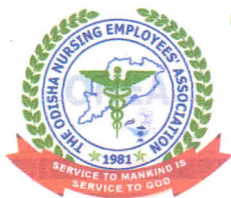
To finalize the modalities and timeline for conducting elections of Branch Representatives of ONEA.
