demands of ONEA, so the members of the Association staged a **Mass Demonstration (Dharna)** at Lower PMG, Bhubaneswar on dt.23.08.2024 without disrupting health care service in the Government run hospitals with a view to draw kind attention of the Government for the neglected Nursing Officers.

It is most relevant to mention here that, during the Mass Demonstration of ONEA on dt.23.08.2024, the delegations of ONEA were invited for a meeting with the Hon'ble Minister, H & FW, Odisha. In the meeting, the Hon'ble Minister, H & FW, Odisha has verbally assured the delegations of the ONEA to take a detailed discussion on each demand in a high level meeting on a suitable date along with the respective higher officials of the Government so as to consider the 10point charter of demands sympathetically and the Hon'ble Minister urged the Association to provide a reasonable time for such purpose. Accordingly, the Association have temporarily deferred its agitation programme giving regards to the verbal assurance of the Hon'ble Minister vide association Letter No.Letter No.281/ONEA/2024 dated 24.08.2024.

In the meantime, nearly a month is going to be over but no such high level meeting has been convened by the Government for the purpose of discussion on the 10point charter of demands of ONEA.

In spite of the fact that when some similar benefits have been extended to other cadre employees, the same are not yet granted to the Nursing Cadre employees.

Accordingly, an emergent GC meeting of the Association was convened on dt.19.09.2024 and held on virtual mode at 9.20p.m. After detailed discussion, all representatives and members of the Association present in that meeting unanimously consented to resume proposed **Cease Work Agitation**

We therefore request you to kindly convene a high level meeting immediately for discussion on fulfillment of 10point charter of demands of ONEA in order to enable all Nursing Officers to refrain from proposed strike in view of public service.
