Sub: Extension of timeline for **renewal of membership** for the year 2025 in the Odisha Nursing Employees' Association.

Respected Sir/Madam,

We would like to inform you that as per the rule provisions prescribed U/r 2 of the Bye-law of Odisha Nursing Employees Association, the renewal of membership in ONEA is mandatory to all members failing which the membership shall be ceased.
