Subject: Eligibility criteria for contesting in ONEA Election 2025-27.

In continuation of the Election Notification dated **14.03.2025**, all members of the **Odisha Nursing Employees Association (ONEA)** are hereby informed about the **eligibility criteria** for contesting in the upcoming election of Office Bearers for the **2025-27 session**.

Eligibility Criteria for Contesting Candidates as per the decision taken in the GC of ONEA:

1. **Active Membership:**

- o The candidate must be a **bona fide member** of ONEA.
- o Membership must be **active** as of the nomination filing date.
- o The candidate must have a **valid ONEA membership card**.

2. **Good Standing:**

- o The candidate must not have any **pending disciplinary actions** or **violations** of ONEA's rules and regulations.

3. **No dual candidacy:**

- o A member can **contest for only one position** in the election.

4. **Nomination endorsement:**

- o Each candidate must be **proposed and seconded** by two active ONEA members.

Important Note:

Candidates failing to meet the above criteria will be **deemed ineligible** to contest in the election.
