Subject: Extension of timeline for membership renewal and nomination submission.

Dear Members,

The Association previously issued several notifications and circulars relating to General Body meeting and election of Office Bearers. Subsequently, the election notifications have been issued on different dates from the Office of the Election Officer. The date of election was 6<sup>th</sup> & 7<sup>th</sup> April, 2025, but due to some unavoidable circumstances, the date of election has been deferred. In accordance with the unanimous decision of the GC meeting of ONEA dated 06.04.2025 communicated to the Election Officer vide letter No.162/ONEA/2025 dated 06.04.2025, the election dates have been rescheduled to be held **on dt.27.04.2025 & 28.04.2025.**

Besides, the date for nomination submission and membership renewal have been rescheduled as follows in the welfare of members so as to provide additional opportunities to members.

○ **Membership renewal deadline extension:**

The membership renewal deadline is extended from dt.07.04.2025 to 13.04.2025.

○ **Nomination submission deadline extension:**

The original deadline for nominations was 21st March 2025 and thereafter extended to dt.26.03.2025. **Now another date i.e 15.04.2025 has been fixed for filling nominations, with the submission time being from 10:00 AM to 5:30 PM.**

○ **Withdrawal of nominations:** 16 April, 2025 (Time:10:00 AM to 5:30 PM)
