- a) To assist the Election Officers in managing the election process.
- b) To ensure impartiality and transparency in election-related activities.
- c) To participate in decision-making on election-related matters.
- d) To resolve election-related issues in consultation with the Election Officers.
- e) To ensure a smooth and fair election process, with decisions finalized based on a **three-fourths** (3/4) **majority consent** among committee members.
- f) To maintain neutrality.

Members intending to contest for an Office Bearer position must resign from the committee before filing nominations.

The Election Officers may convene meetings of the Election Coordination Committee as needed to address any exigencies and facilitate the election process.

All ONEA members are requested to extend their full cooperation to the Election Officers and Coordination Committee for the smooth conduct of **ONEA Elections 2025**.

This notification is issued with the approval of the General Council of ONEA and shall come into immediate effect.
