It is hereby notified for information of all concerned members that the election of Branch Representatives of ONEA in certain districts/MCHs has not yet been conducted. It has further come to the notice of the State Association that in some districts where elections have been conducted, the prescribed procedures/ parameters as laid down in the Notification of ONEA dated 13.08.2025 have not been duly followed.

In pursuance of the resolution passed in the meeting of the State Executive Committee of ONEA held on 31.03.2026, all concerned Branch Associations of districts where elections are yet to be conducted are hereby **requested to complete the election process on or before 07.05.2026, strictly in accordance with the procedures and parameters stipulated in the aforesaid Notification dated 13.08.2025 (Copy enclosed).**

It is further notified that in the event of failure to comply within the stipulated period, the State ONEA shall be constrained to initiate and complete the election process of such defaulting districts/MCHs through virtual mode/appropriate alternative mode, as deemed fit and no subsequent objection, grievance or representation in this regard shall be entertained.
